THE ROYAL GOLD SET

The only complete date run of this denomination in private hands

The largest denomination of gold coin struck in the British series, was the gold "Five Guinea" piece originally introduced at a face value of Five Pounds or 100 Shillings from 1668 in the reign of King Charles II (1660-1685).

The gold Guinea of 20 Shillings had been introduced as a modern machine made coin from 1663, followed by the Double Guinea of 40 Shillings in 1664, so it may seem only natural that a 100 Shilling piece should follow from 1668 as a coin of national pride, to compete with the other large gold coins issued in other European countries, and perhaps as pieces of pleasure for Royalty to exchange for services or as gifts.

The denomination of the Five Guineas as a physical coin was struck for a period of 110 years in total, with the last being dated 1777 as a pattern piece in the reign of George III (1760-1820) one of three dates minted for a proposed coinage. Otherwise the gold Five Guineas had an 86-year currency date range from 1668-1753 inclusive of which 46 actual dates were actually produced.

The Royal Gold Set is one of the most complete run of gold Five Guineas ever formed privately and is most significantly the only time that all 49 dates have ever been successfully put together.

We would like to take this opportunity to thank Mr Ian Goldbart (Sovereign Rarities) for his help and valuable comments.

Some of the coin descriptions published here are coming from previous sales. We thought it appropriate to include them for their poetic and well-found character.

CHARLES II, 1660 - 1685

Charles II, popularly known as the "Merry Monarch" was born on May 29th 1630. He was the first survived son of Charles I and Henrietta Maria, the sister of the French king Louis XIII. Charles was proclaimed king of Scotland after the execution of his father in 1649 till his defeat in 1651 by Cromwell.

He then spent nine years in exile in France, the Dutch Republic and the Spanish Netherlands. Following the restoration of the monarchy and the death of Cromwell, Charles was invited to return to Britain in 1658. On the 29th of May 1660, at the age of thirty he was received in London to public acclaim and acceded to the throne of England, Scotland and Ireland until his death in 1685. Baptized in the Chapel Royal on the 27th of June by the Anglican Bishop of London he was received into the Roman Catholic Church on his deathbed. With no legitimate descendant his brother James succeeded him.

Engraved by John Roettier, this obverse is much rarer than the obverse with the elephant. Bearing the edge year for 1669, this coin is therefore evidence that the elephant type Five Guineas of 1668 was struck before the non-elephant variety.

The elephant or the elephant with castle is the badge of the Royal African Company that supplied gold bullion to make this coinage. In 1663, King Charles II sold the control of Africa trade to "The Company of Royal Adventurers of England Trading to Africa". Then the Royal African Company was established in 1672, and was sold a monopoly of trade to Africa. The coin, first issued in 1663, was called after the coast of Guinea in West Africa, which was the source of much of the gold then traded to Britain. There was a demand from merchants outside London to be allowed to share in this profitable trade. This demand led to a change in its organization. In 1698 the Royal African Company lost its monopoly over the trade. Any merchant could now join in the trade to Africa.

JAMES II, 1685-1688

James II, born on the 14th of October 1633 was the second surviving son of Charles I and ascended the throne after the death of his brother, Charles II. He governed England and Ireland as James II and Scotland as James VII. He was the last Roman Catholic monarch until his deposition during the Glorious Revolution in 1688. Despite struggling with the English Parliament and the English Civil War he attempted to establish the religious liberty especially for English Roman Catholics and Protestant nonconformists. Being obliged to abdicate he was replaced by his Protestant daughter Mary and her husband William of Orange.

WILLIAM III AND MARY II, 1689-1694

The joint reign of William and Mary began in - February 1689 after the defeat of James II -Mary's father. The Dutch Prince of Orange, King William III married his first cousin Mary Stuart and future Queen Mary II in 1677. They ended the tensions and conflicts between the Crown and Parliament by signing the English Bill of Rights of 1689 and introduced the stamp duty under «An act for granting to their Majesties several duties upon vellum, parchment and paper, for four years, towards carrying on the war against France». In 1693 the College of William & Mary was founded in Virginia in America. It was named in honor of the reigning monarchs. After the death of Mary in 1694, William became the sole ruler succeeded by Mary's younger sister, Anne.

WILLIAM III, SOLE REIGN, 1694-1702

W illiam III was born on the 4th of November 1650 as the only son of William II and Mary, Princess Royal and daughter of King Charles I of England. Widely known as William of Orange, the principality of which he inherited at his birth, he also had various titles: Stadtholder of Holland, Zeeland, Utrecht, Gelderland, and Overijssel in the Dutch Republic from 1672. Supported by influential British political and religious leaders he invaded England in «Glorious Revolution». He raised to power after the deposition of James II in 1689 and remained King of England, Ireland and Scotland until his death in 1702.

ANNE, 1702-1714

Anne was born on the 6th of February in 1665. Although her father James II was a Roman Catholic, she was raised as an Anglican. She became Queen of England, Scotland and Ireland in 1702. In 1707, following the union of two kingdoms: England and Scotland, she was proclaimed the Queen of Great Britain and Ireland until her death in 1714. With no survived descendant she remained the last monarch of the House of Stuart. Under the Act of Settlement from 1701 which carried favour for the Protestants in the succession to the English and Irish throne, she was succeeded by her second cousin George I of the House of Hanover.

VIGO below the bust signifies this gold was minted from gold bullion captured from the Spanish after the Battle of Vigo Bay. Despite the fact that only an estimated 20 specimens were struck of this great rarity, three different varieties were created. Each variety has different positioning of the work VIGO and the portrait of the Queen Anne is positioned differently. According to Greg Holloway, the Mint was experimenting with different designs to see which might be acceptable to the Queen. These coins could be considered patterns as they predated the roll out of the rest of the Anne 5 Guineas series. GEORGE I, 1714-1727

George I was born on the 28th of May 1660 in Hanover. He inherited the lands and the titles of Duchy of Brunswick-Lüneburg, which belonged to his father and uncles. Although he mainly lived in Great Britain after the election, he used to visit his home in Hanover and spent about one fifth of his reign as King of Great Britain and Ireland in Germany. He ascended the English throne at age of 54, after the death of Queen Anne of Great Britain, his second cousin. His reign was marked by the transition to the modern system called the Cabinet Government with the important role of a prime minister. His son, George Augustus succeeded him as George II.

GEORGE II, 1727-1760

George II was born on the 10th November 1683 in Hanover. Like his father, he was brought up outside Great Britain – in northern Germany. He succeeded George I and become King of Great Britain and Ireland, Duke of Brunswick-Lüneburg and Prince-elector of the Holy Roman Empire from 1727 until his death. Following the new parliamentary system of Great Britain, he exercised little control over British domestic government policy. His involvement in the Battle of Dettingen in 1743 earned him the status of last British monarch who led an army in battle. He was succeeded by his grandson George III.

The gold used to strike this coin was supplied by the East India Company which initial letters appear on obverse. This company received a Royal Charter from Queen Elizabeth in 1600, making it the oldest among several similarly formed European East India Companies. Wealthy merchants and aristocrats owned the Company's shares. The government owned no shares and had only indirect control. The company eventually came to rule large areas of India with its own private armies, exercising military power and assuming administrative functions. Company rule in India effectively began in 1757 after the Battle of Plassey and lasted until 1858 when, following the Indian Rebellion of 1857, the Government of India Act let to the British Crown to assume direct control of India.

The LIMA privy mark is still a mystery. In a book on English coinage published in 1762, Thomas Snelling wrote that the precious metal was brought back by George Anson from his circumnavigation around the world. In June 1743, Anson captured the "Nuestra Señora de Covadonga", a Spanish ship on its way to the Philippines from South America. The ship was carrying 1,313,843 pieces of silver eight reales. But no gold is mentioned and it is said that Anson took his prize to Macao and sold the cargo to the Chinese. In 1745, another great treasure of silver coins was seized in the North Atlantic by two British privateers from two French treasure ships that were coming from Peru. The booty was transported in forty-five wagon loads from the port of Bristol to the mint of London. One more time, no gold is mentioned. The small number of LIMA Five Guineas – and thus the probable small amount of gold – could explain that the metal was never mentioned. So its exact provenience remains unknown.

GEORGE III, 1760-1820

George III was born on the 4th of June 1738 as a grandson of King George II. He governed the Great Britain and Ireland from 1760. After the union of the two countries he was proclaimed King of United Kingdom of Great Britain and Ireland until his death in 1820. Although he was born in Great Britain, he was also the third British monarch of the House of Hanover. During his long reign his kingdoms were involved in several military conflicts worldwide: Africa, the Americas and Asia. His battle against the Napoleonic France ended successfully with the defeat of Napoleon at the Battle of Waterloo in 1815. After his death, his eldest son, George, Prince of Wales succeeded him.



THE THREE MOST IMPORTANT 5 GUINEA PATTERNS

The last issue of the Five Guinea piece was in 1753 during the reign of George II. It may be that there was the intention to issue Five Guinea pieces for George III, as the engraver Johann Tanner produced several pattern designs in 1770, 1773 and 1777. Perhaps the War of Independence in America and then Napoleonic Wars halted any possibility of circulating anymore such large gold coins, and as banknotes slowly were introduced into everyday transactions, the Five Guinea piece was no longer needed or viable as the gold could be used for British economic assets in a vastly changing industrially revolutionized world. It is likely that these three patterns represent serious proposals for regular issue coinage and there is a good chance that all three proposals were very seriously considered. These three are among the most important patterns in the history of British coinage, as they are gold denominations produced in an official manner by the Royal Mint in London.

GENERAL CONDITIONS FOR AUCTION SALE (2024)

These general conditions, which are also available on the website www.ngsa.ch, are deemed to be accepted without reserve by all and any person attending the auction sale conducted according to the I.A.P.N. rules or taking part to the auction sale. The general conditions may be amended orally or in writing by Numismatica Genevensis SA (hereinafter referred to as "NGSA"); such amendment would be referred to in the minutes of the auction sale.

The general conditions exist in French and in English. In case of discrepancy between the two versions, the French version shall prevail.

1 Checking the goods and mandatory registration

- 1.1 Potential buyers are required to check the goods put up at auction prior to the sale, especially during their exhibition.
- 1.2 Any potential buyer must register with NGSA prior to the beginning of the auction sale by filing and signing a questionnaire and by showing his/her identity card or valid passport, prior to the sale. The potential buyer will then receive from NGSA a personal identification number allowing to bid during the auction. The potential buyer will be liable for all damages resulting from any misstatement in the questionnaire.
- 1.3 NGSA will systematically refuse to grant the access to the auction sale for potential buyers who will not have duly filed and signed the registration questionnaire or who will have not provided NGSA with a valid identity card or passport.
- 1.4 NGSA reserves its discretionary right to refuse to anybody, the access to the sale and the auction hall.

2 Agency

- 2.1 Bidders are deemed to act in their own name and they will be personally liable for their bid; bidders are especially personally liable for the payment of the purchase price, of all costs, taxes and commissions in relation with the allocated to them goods.
- 2.2 Bidders are however authorised to act in the name of a third represented party, subject to the twofold condition that (i) their powers are documented through a proxy duly signed by the third party and that (ii) the latter has been identified and accepted by NGSA prior to the sale. In case of authorised agency, the third represented party will be bound by these general conditions.

3 Guarantee of NGSA

3.1 Descriptions given in this catalogue are given in good faith. The authenticity of coins and medals is guaranteed to each participant in the bid for the total purchase price.

4 Bidding

- 4.1 The sales follow the sequence shown in the catalogue. The prices in the catalogue are initial prices.
- 4.2 Notwithstanding the above, the auctioneer reserves the discretionary right to change the sequence shown in the catalogue and/or to split or join any goods and/or lots.
- 4.3 The auctioneer also reserves the discretionary right to withdraw any good or lot from the auction sale, and/or to interrupt the auction sale.
- 4.4 The bid made by a bidder is irrevocable and definitive. It cannot be withdrawn.

5 Auctionning

- 5.1 The prices are indicated in Swiss francs.
- 5.2 Subject to clause 4 para 3, the higher bid gets the auction.
- 5.3 During the auction, NGSA executes bid orders that will have been received in writing by NGSA before the auction sale. Where several bid orders have been received for the same good or lot and for the same amount, the first bid order shall prevail. Written or telephone bidding requests must be received no later than 24 hours before the start of the auction. NGSA accepts no responsibility for bids made by telephone, in writing or via a live bidding platform.
- 5.4 In case of dispute between two bidders, the auctioneer may cancel the sale for the concerned good or lot and put it immediately up for auction at the price offered by the above mentioned bidders, any attendee being entitled to bid again.
- 5.5 Risks and profits will be transferred to bidder upon auctioning. However, title passes to bidder only when the purchased good or lot is remitted to bidder and when the full payment (especially the payment of the purchase price, of all costs, taxes and commissions in relation with the allocated to them goods) is settled by the bidders.

6 Payment

6.1 Any bidder commits to settle personally the auction price, as well as all and any costs to be borne by the bidder, as well as all taxes due in connection with the auction sale.

- 7.2 In reference to clause 6.4, NGSA has no liability whatsoever for any damage resulting from the breach by the bidder of any customs regulations, foreign currency exchange regulations and any other regulations abroad.

8 Governing law and jurisdiction

- 8.1 These conditions of sale and their subsequent amendments shall be subjects to Swiss law and interpreted according to Swiss law, not including private international law.
- 8.2 Any dispute regarding their validity, effect, interpretation, execution or non-execution shall be, notwithstanding the parties' domicile or seat, within the exclusive jurisdiction of the Courts of the Canton of Geneva, subject to appeal to the Swiss Federal Tribunal, in Lausanne.


